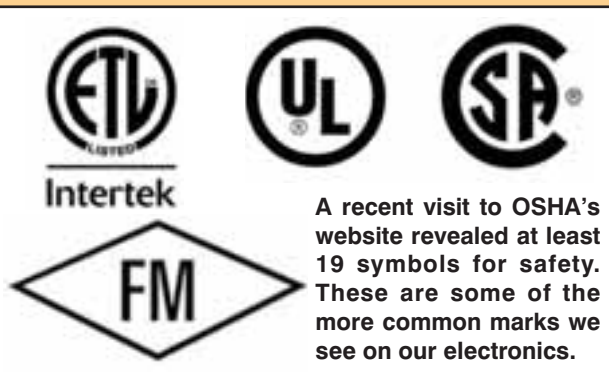
Safety

Have yourself a safe, merry little Christmas

The holiday shopping season is underway. Many stores, radio stations and TV channels are now devoted to bombarding us with holiday sales 24/7. With this kind of aggressive promotion we are starting to think about shopping for our loved ones. However, before we start gift giving, keep safety in mind.

Whether you shop Black Friday, Cyber Monday or last minute, make it a habit to check and see if their “great deal” was tested and certified by a nationally recognized testing lab. These labs ensure that electronics meet current safety standards and are safe to use by their owners when used correctly.

A National Recognized Testing Laboratory (NRTL) is a third-party organization that certifies products for the North American market. When the products involve a workplace, NRTLs are recognized by the Occupational Safety and Health Administration (OSHA) under Federal Code 29 CFR 1910.7 to provide product safety testing and certification for products to be used in the U.S.



A recent visit to OSHA's website revealed at least 19 symbols for safety. These are some of the more common marks we see on our electronics.

To receive and maintain certification the NRTLs:

1. Evaluate and test products to safety standards.
2. Address any standards with compliance issues with the manufacturers.
3. Authorizes manufacturers to apply certification marks to eligible products.
4. Conducts factory inspections for all certified products.
5. Provides assurance that

products are tested as safe for their intended use in the U.S.

Don't be fooled by a good deal. There's more to consider about a product than just its price. Look for the right safety mark on the holiday gifts you buy, as well. An unsafe condition might be lurking inside the gift-wrapped package you bought for a loved one. That unsafe condition could make that good deal one of the most costly purchases you ever make.

Everyone wants a good deal. Safety symbols let consumers know that they are getting safe value for their money, as well. (E)

Operation Round Up distributes more than \$9,500

Thanks to contributions from members whose electric bills are “rounded up” to the nearest dollar each month, Brown County REA’s Operation Round Up contributed more than \$9,500 to 30 organizations and individuals in 2018. The Round Up Trust also awarded its first scholarships to five area students.

Each month participating BCREA members “round up” their electric bill payment to the nearest dollar. For example, if your electric bill is \$85.56, you pay \$86. The extra 44 cents goes into the Round Up Trust account and becomes part of the funds distributed to worthy causes

throughout our service area. Your less than \$12 annual contribution helps make a difference when your change is pooled with other members’ contributions to provide support to area charitable organizations, individuals in crisis and scholarships to high school seniors.

Among the organizations to receive Operation Round Up contributions this year were Network New Ulm Youth Leadership, Kiwanis Coats for Kids, Sleepy Eye Sportsmen’s Boating and Bobbers, Brown County Free Fair, Comfrey Legion Auxiliary, Sleepy Eye Firearms Safety, Minnesota Brain Injury Force, Holiday Lights in Motion, Brown County and Nicollet County 4-H, plus projects for police departments, fire and rescue squads throughout the service area.

Since the Round Up program began at BCREA in 1995, just over \$193,100 has been donated to organizations and individuals in the co-op’s service area.

A heartfelt “thank you” goes out to the Brown County REA members who participate in Operation Round Up. The summary of your tax-deductible contributions for 2018 were printed on your December electric bill. \$2,550 granted at final 2018 meeting

BCREA Director candidates sought

Interested or know of someone who may be interested in running for a position as Director for your electric cooperative? Nominations are being sought for candidates to run for election in BCREA's Districts 1, 4 and 5.

District 1 is made up of Stately, Bashaw, Burnstown and portions of North Star Townships, the city of Comfrey in Brown County, a portion of Brookville Township in Redwood County and part of Delton Township in Cottonwood County. District 4 covers Sigel and Cottonwood Townships in Brown County and part of Cambria Township in Blue Earth County. District 5 consists of Stark and Leavenworth Townships in Brown County.

Nominating Committees are made up of three members from each of the districts up for election. Per the cooperative's by-laws, the nominating committee will nominate at least two candidates for each directorship at least 35 days before the Annual Meeting. In addition, any 10 or more cooperative members residing in the district may submit a nomination with their signatures for a director in their district. Nominations may also be made for a member residing in the district by another member who resides in the district at the annual meeting.

Members residing in District 1, 4 or 5 who are interested in being a director candidate, please complete and return the Director Candidate Application. Your name will be shared with the nomination committee for consideration as a candidate.

Directors will be elected at the 82nd Annual Meeting April 11, 2019 at the Sleepy Eye Event Center.

- I am not a full-time employee or agent of, nor am I the full-time employer or principal of, another director.
- I will notify the appropriate authority of the cooperative in the event that any of the foregoing certification should change prior to the upcoming election or, should I be elected a director, should any of the foregoing certifications not continue to apply to me as serving director of the cooperative.

Salted Caramel Butter Bars by Julie Goering, Jackson

Crust: 2 c. salted butter, room temperature
 1 c. white sugar 1½ c. powdered sugar
 2 T. vanilla 4 c. flour

Filling: 14 oz. soft caramel candies (about 50 unwrapped)
 1/3 c. milk or cream ½ tsp. vanilla 1 T. coarse sea salt, optional

Crust: Preheat the oven to 325°. Coat 9x13" baking dish with nonstick spray. Set aside. In the mixing bowl fitted with the paddle attachment mix the butter and both sugars on medium speed for two minutes. Add the vanilla and mix until combined. Turn the mixer to low and add in the flour, mixing until a soft dough forms. Press one-third of the dough evenly into the bottom of the prepared pan. Wrap the remaining dough in plastic wrap and chill in the refrigerator. Bake for 20 minutes or until the edges are a pale golden brown. Transfer the pan to a wire rack and let cool about 15 minutes.

Filling: While the bottom crust is baking and remaining dough is chilling, make the caramel filling. Place the unwrapped caramels in a microwave-safe bowl. Add the milk or cream. Microwave on high for one minute. Remove from the microwave and stir until smooth. If the caramels are not completely melted, microwave on high for 30-second intervals, stirring after each interval, until smooth. Once the caramel is melted, add the vanilla and stir. Pour the caramel filling over the cooled crust. If you are going to salt the caramel, sprinkle it on the caramel layer now. Remove the remaining chilled dough from the refrigerator and crumble it evenly over the caramel. Return the pan to the oven; bake until the filling is bubbly and the crumbled shortbread topping is firm and lightly golden (about 25-30 minutes). Let cool completely before cutting into squares. 📧

Any time you or an electrician does wiring or other electrical work at your home or farm, Minnesota state

law requires a state wiring inspector to conduct a proper inspection of the work. A rough-in inspection must be made before any wiring is covered. A final inspection is also required. The local inspectors are:
