2026 Annual Meeting

When you purchase electricity from Brown County REA, you are more than just a customer – you are a member-owner. Being a member and owner of a rural electric cooperative means you have a say in how the cooperative operates.

One of the best ways to get involved with your cooperative is by attending our annual meeting, held this year on Thursday, April 9th at Sleepy Eye Event Center. If you've never been to one of our annual meetings before, I encourage you to make plans to attend and learn more about your cooperative. If you are a regular attendee, I thank you for your continued interest and support.

The 89th Annual Meeting of Brown County REA starts with registration and live music at 4:30 p.m. Beginning at 5:30 p.m., members are invited to join us for a meal, followed immediately by the business meeting. Attendees will have an opportunity to hear about the financial condition of the cooperative and learn more about the programs and services we offer.

An important part of each year's meeting is the election of directors to Brown County REA's Board of

Directors. These individuals are responsible for conducting the business of the cooperative. Brown County REA's service territory is divided into nine districts, with each district having an elected director to represent them on the Board. This year, members will be electing directors in Districts 2, 3, and 8.

Voting in the director election gives you a way to actively participate in deciding who is elected to set policies and make decisions that impact the cooperative. Directors are elected among the membership and are accountable to them. This concept of Democratic Member Control is one of the foundational principles all cooperatives adhere to.

One final reminder about voting: there will be no mail-in balloting this year. To cast your vote in the upcoming director election, you will need to be present at the annual meeting to vote.

District 2

Brad Sprenger, Incumbent

Brian values the cooperative principles of service, integrity, and accountability. He would be committed to making a positive difference in the community as a BCREA director.



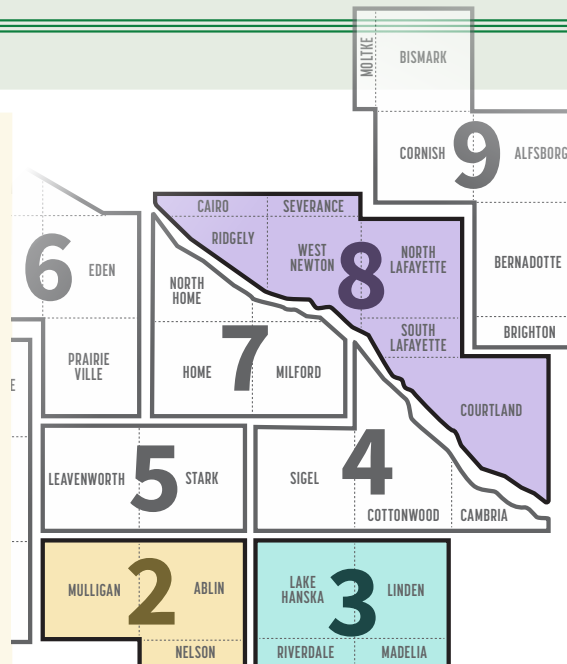
Craig Fischer

Craig and his wife, Elizabeth, live on the family farm south of Sleepy Eye that he grew up on. They have three children: Bryce, Logan, and Gavin. Craig graduated from New Ulm Cathedral High School and Minnesota State University Mankato with a degree in Institutional Finance.

Craig worked for the City of Sleepy Eye for 10 years before transitioning to the family farm. In 2013, he founded Sleepy Bison Acres, a diversified farm that raises bison for meat production, pastured pigs, and egg-laying chickens. The operation also produces hay and various cash crops using no-till practices, drip irrigation, and cover crops, including space dedicated to education. Craig also helps manage his wife's food trailer, Sleepy Bison Grill, which operates across the Midwest. The Craig and Elizabeth Fischer family was named the 2025 Brown County Farm Family of the Year.

Craig has served as Chair of the Brown County Soil and Water District Board since 2021 and has been a board member of the Minnesota Bison Association Board since 2016. He has experience on the Minnesota Grown Advisory Committee and is active in the National Independent Concessionaires Association, National Bison Association, Minnesota Farmers Union, Practical Farmers of Iowa, The Land Stewardship Project, and the Sustainable Farming Association.

Craig is interested in continuing to build on BCREA's foundational focus of positive, low-cost, and reliable service, while adapting to the current challenges of changing regulations and rising costs as a BCREA director.



District 3

Landon Sletta, Incumbent

Landon has lived his entire life in the Hanska area. He is a graduate of New Ulm High School and attended Mankato State University where he studied Business.

Annual Line Patrol Underway

Brown County REA crews are continuing their annual line patrol. During this time, crews may need to access yards and private property throughout the service area. Linemen will be inspecting equipment and infrastructure to identify maintenance needs, including loose or missing guy wires and guards, damaged lines, and proper line clearance. Crews will also perform maintenance on OCRs, as well as overhead and underground lines. This work will continue through early spring.

HASHBROWN CASSEROLE **RECIPE**

INGREDIENTS

1 package (2 pound)
frozen hashbrown
potatoes, thawed

1 can (10.5 ounce)
condensed cream of
chicken soup

2 cups shredded
cheddar cheese

1 container (8 ounce)
sour cream

1 cup butter, melted,
divided

½ cup chopped onion

½ teaspoon salt

½ teaspoon ground
black pepper

1 cup crushed
cornflakes or
crackers

INSTRUCTIONS

1. Gather all ingredients. Preheat the oven to 350° F.
2. Mix hashbrowns, cheddar cheese, condensed soup, sour cream, ½ of the melted butter, onion, salt, and pepper in a bowl. Transfer mixture to a 9x13-inch baking dish.
3. Sprinkle crushed cornflakes/crackers on top, then drizzle with remaining melted butter.
4. Bake in the preheated oven until casserole is bubbling around the edges and the top is golden brown (1 hour to 1 hour 30 minutes).
5. Serve and enjoy!
