Your guide to energy efficient appliances

When you consider your next appliance purchase, you are encouraged to purchase an ENERGY STAR® qualified appliance. Your cooperative offers rebates for members who purchase an ENERGY STAR-qualified refrigerator or freezer as long as the replaced unit is properly recycled. Members can also receive a rebate for purchasing ENERGY STAR electric clothes dryers and dehumidifiers.

DEHUMIDIFIERS

- ENERGY STAR-certified dehumidifiers have more efficient refrigeration coils, compressors, and fans than conventional models, which means they remove the same amount of moisture but use nearly 30% less energy.
- In fact, the annual energy saved by an ENERGY STAR certified dehumidifier could power your ENERGY STAR certified refrigerator for four months!

By choosing ENERGY STAR, a typical household can save about \$450 on their energy bills each year and still enjoy the quality and performance they expect.

ELECTRIC CLOTHES DRYERS

- ENERGY STAR certified dryers use about 20% less energy than conventional models without sacrificing features or performance.
- You can save about \$20 a year in electricity compared to the dryers that only meet the minimum efficiency standard.

FREEZERS

- Freezers that have earned the ENERGY STAR are at least 10% more energy efficient than the minimum federal standard.
- Replacing your old freezer with one that has earned the ENERGY STAR could save you approximately \$35 a year.

REFRIGERATORS

- ENERGY STAR certified refrigerators are about 9% more energy efficient than models that meet the federal minimum energy efficiency standard.
- By properly recycling your old refrigerator and replacing it with a new ENERGY STAR certified refrigerator, you can save approximately \$50 a year.
